


My.SSS ONLINE LOAN PROCEDURE

**FOR INDIVIDUAL
MEMBERS**


STEP 1.

Visit the My.SSS Portal (<https://member.sss.gov.ph>). Enter your User ID and Passwords then click “Sign In”



STEP 2.

- After logging-in to the Member account, select “Loans” and click “Salary Loan”. For employed members, salary loan application submitted online will be directed to the My.SSS account of the employer for certification.

If eligible for a salary loan, your employer and loanable amount will be displayed. You may opt to select a lower loan amount. Read the terms and conditions carefully and click on **“I agree to the Terms and Conditions”** then click the **“Proceed”** button. Once your salary loan is submitted, your employer is given three (3) working days to certify (reject or approve) your salary loan; otherwise, it will expire and you will need to repeat the process.
